WHY APPLY FOR FINANCIAL AID?

Submitting a financial aid application is the single most important thing you can do to get money for college. Most students receive some type of aid, so you should submit an application even if you don't think you qualify. The time you spend completing an application could translate into hundreds or even thousands of dollars that can help you pay for college.

SUPPORT SERVICES

WELCOME CENTER

Take advantage of our in-person services in the Welcome Center for assistance with all of your financial aid needs. From the application process to navigating the world of financial aid and scholarships, SFS is ready to assist you. Visit the lobby desk in the Welcome Center and you'll be directed to our front counter.

SFS COUNSELORS

Student Financial Services Counselors are available to provide support so you can stay on your pathway to success. We strongly encourage you to meet with an SFS counselor as soon as possible if you:

- Are considering withdrawing from a course or are in danger of not passing a course
- Have received a financial aid warning email
- Have received a financial aid ineligible email
- Need to create or update your Student Educational Plan (SEP)

LEARN ABOUT CONEXED >

ConexEd is a platform that allows students to connect with departments and services, online, regardless of your physical location. With ConexEd, you can drop in to virtual offices, make appointments, send messages and ask important questions to the Student Financial Services team. Simply visit the ConexEd login page for MVC. Your student email and password will allow you to sign in.

FAFSA

If you need financial assistance to pay for college, don't miss out! Submit the FAFSA, include Moreno Valley College's school code 041735 on your application, and ensure your social security number is on file with Admissions and Records. Federal and state funds, including grants and scholarships, remain available for scholars year-round.

Submitting the FAFSA is the first step. Check your file status and complete pending actions at the StudentForms financial aid portal and follow up on all requests from SFS.

CADAA

There are many financial aid options for undocumented/dreamer students. If you are undocumented and have been determined AB 540 eligible by Admissions and Records, submit the California Dream Act Application (CADAA) and include the MVC school code 04173500.

CADAA information is private! The CADAA does not link applicant information to federal government databases. The California Student Aid Commission (CSAC) keeps CADAA applicant data confidential. CADAA data will not be shared with, or disclosed to, any federal agencies, including immigration enforcement.

2024-2025 FAFSA CHANGES

UPDATE! There are a number of benefits of the FAFSA Simplification Act, including a more streamlined application process and a better user experience for the FAFSA, expanded eligibility for federal student aid, and reduced barriers for certain student populations.

Here are a few notable changes to the 2024-2025 application:

2024-2025 FAFSA OPENING

This year the FAFSA will open in **December 2023.**

A SHORTER AND MORE STREAMLINED APPLICATION

The FAFSA will greatly reduce the maximum number of questions. This streamlined format will simplify the application process for students and families.

AVAILABLE IN MORE LANGUAGES

The 2024-25 application will be expanded from English/Spanish to include the 11 most common languages spoken by English learner students and their parents.

APPLICANTS REQUIRED TO USE THE IRS DIRECT DATA EXCHANGE

All persons on the FAFSA must provide consent for the Department of Education to receive tax information or confirmation of non-filing status directly from the IRS.

ALL "CONTRIBUTORS" MUST PROVIDE FINANCIAL INFORMATION

A contributor—a new term being introduced for 2024-25—refers to anyone who is required to provide information on a student's form (such as a parent/stepparent or spouse).

STUDENT AID INDEX (SAI) REPLACING EXPECTED FAMILY CONTRIBUTION (EFC)

This name more accurately describes the number used to determine aid eligibility and, unlike the EFC, the SAI may be a negative number down to -1500, which may help the neediest students receive the maximum amount of aid.

NO LONGER CONSIDER FAMILY MEMBERS IN COLLEGE

The application will still ask how many household members are in college, but your answer will not be calculated into the SAI.

PELL GRANT ELIGIBILITY EXPANDED

The FAFSA Simplification Act expands the Federal Pell Grant to more students and links eligibility to family size and the federal poverty level.

INFORMATION FOR DIVORCED OR SEPARATED PARENTS

With the new FAFSA, for dependent students, financial information will be required from the parent(s) who provided the most financial support to the student.

FSA ID NOW AVAILABLE TO PARENTS WITHOUT A SSN

Currently those without a SSN are not able to electronically sign the application and have to mail in a paper signature form. The new FAFSA, will allow the FAFSA to be signed and submitted electronically for most students.



WEBGRANTS FOR STUDENTS (WG4S)

WG4S will allow you to manage your Cal Grant and/or Chafee account(s) online by letting you view updates, make school & address changes, and post leave of absence requests. *Note: your WG4S account does not replace your MVC or FAFSA accounts.*

CHECK YOUR AWARD STATUS

Students should monitor their WebGrants 4 Students portal to confirm their award status for the Cal Grant and the Chafee Grant for foster youth. If your Award Status is pending, click on the "To Do" list to determine next steps. If your Award Status is "Not Awarded", click the "Reason" button to learn more and consult with MVC SFS or CSAC if you believe there is an error.









- Check your award status and award amount.
- Verify if there are any pending items or forms that still need to be completed.
- Confirm that your school of attendance is MVC. This refers to the college you plan to attend, not your high school.
- Verify that your GPA has been received. If not, contact your high school or college counselor or the California Student Aid Commission (CSAC).
- Verify your high school graduation date. This will become available on the 1st day of the month of your planned graduation.
- Students with Dependents can certify their eligibility.
- If you applied for the Chafee Grant, check that your "Department of Social Services Record" is complete to verify your foster youth status. *Note: This is verified monthly so it may take up to 6 weeks before you see results.*

STUDENT SUCCESS COMPLETION GRANT (SSCG)

The Student Success Completion Grant is administered by the California Community Colleges and provides a grant award to students that are enrolled in 12 or more units, receive the Cal Grant B or C, and are California residents or meet the requirements for a non-resident tuition exemption. Students must also meet Satisfactory Academic Progress (SAP) standards to receive the SSCG.

Eligibility for non-foster students:

- Students enrolled in at least 12 but fewer than 15 semester units receive **\$1298** per semester (\$2596 annually).
- Students enrolled in 15 or more semester units receive **\$4,000** per semester (\$8,000 annually).

SSCG INCREASE FOR FOSTER YOUTH!

UPDATE! SB 117 increased the grant amount for current and former foster youth beginning with the 2023-2024 academic year. Current and former foster youth is defined as a person whose dependency was established or continued on or after the age of 13.



Eligibility for current and former foster youth:

• Students enrolled in 12 or more units receive **\$5,250** per semester.

CAL GRANT PRIORITY APPLICATION DEADLINE EXTENSION



UPDATE! The Department of Education has announced that due to the upcoming FAFSA changes, the 2024-25 FAFSA and CADAA are scheduled to be released in **December 2023**. Because of the later than usual release date, which is typically October 1 of each year, the Cal Grant priority application deadline has been extended from March 2, 2024 to **April 2, 2024**. This change will allow students additional time to submit their FAFSA's and ensure their GPA has been submitted for 2024-25 Cal Grant consideration.

CAL GRANT ACCESS AWARDS

STUDENTS WITH DEPENDENT CHILDREN (SWD)

If you are a Cal Grant recipient attending Moreno Valley College who has dependent children, you may be eligible for the Students with Dependent Children (SWD) Grant which increases the Cal Grant award by up to \$6,000 for qualifying Cal Grant B recipients and up to \$4,000 for qualifying Cal Grant C recipients.



To qualify, the student must have dependent children that are under 18 years of age for whom they provide more than half of their financial support during the academic year and indicate they have a child/children on their FAFSA or CADAA. About a week after submitting your application, log in to your WebGrants for Students account to self-certify your dependent children. The student MUST complete the certification to be awarded.

CAL GRANT B FOR FOSTER YOUTH

This access award provides current and former foster youth increased Cal Grant eligibility of up to \$6,000 per year, renewal for the equivalent of eight years of full-time attendance in an undergraduate program, they have until age 26 to apply for the Cal Grant High School Entitlement Award, and they can apply for a High School Entitlement award through September 2, at a California Community College. Students can receive this access award in addition to the Chafee Grant.

CHAFEE GRANT DISBURSEMENTS



UPDATE! The Chafee Grant for Foster Youth is now disbursed through BankMobile. If you've already selected a disbursement preference, no further action is required. If you've never received financial aid at MVC, check your student email for account setup instructions.

THE CALIFORNIA DREAM ACT SERVICE INCENTIVE GRANT PROGRAM (DSIG)

DSIG is a great way for eligible undocumented students to access paid professional development, even without work authorization! The California Student Aid Commission (CSAC)

will award up to \$4,500 per academic year (up to \$2,250 per semester) to 1,667 eligible students. Eligible students must be receiving a Cal Grant B award, maintaining Satisfactory Academic Progress, be a California resident, enrolled in at least half-time, and demonstrate enough financial need.

- Download, complete, and submit the Grant Application form.
- Complete 150 hours per semester of community or volunteer service.
- 3 Download, complete, and submit the Payment Request form; include verification of hours.

DID YOU KNOW? Students can volunteer on campus. All Cal Grant eligible colleges qualify as service organizations. MVC centers and departments can host volunteers to support your work!

FREE LEGAL ASSISTANCE FOR MVC DREAMERS

TODEC's free legal services for immigrants and community members is one of the core services offered. Everyone should have the support they need to navigate the U.S. legal system and access resources. Their probono legal services and clinics make sure that everyone has the legal support they need to protect their families.

The Perris-based legal center provides local residents with free DACA renewal application, legal and USCIS fee help. Take advantage of their free services by filling our the online application form. A TODEC staff member will follow up with your request. You will receive a telephone call from their scheduling department 1 to 4 business days after your request is received, excluding Holidays observed and Weekends.

Support is available in both English and Spanish.

ACCESSING VITAL DOCUMENTS FOR YOUTHS EXPERIENCING HOMELESSNESS

California state laws give children and youth experiencing homelessness the right to get their birth certificates and IDs at no cost and without the signature of a parent or guardian, even if you're under 18.

If any one of these situations applies to you:

- You are staying in a home that is not yours, your parent's or legal guardian's because you had to leave your home.
- You are in an unstable living situation, without a safe or steady home.
- You are sleeping in a motel, car, tent, abandoned building, or public place
- You are staying in a shelter or transitional living program

It's easier than ever! If you were born in California, find out how you can access your free birth certificate and ID.





THE SCHOOLHOUSE CONNECTION SCHOLARSHIP PROGRAM

Schoolhouse Connection, a national non-profit organization working to overcome homelessness through education, is now accepting applications for their Youth Leadership and Scholarship Program for high school students graduating in spring 2024.

ABOUT THE SCHOLARSHIP

- \$2,500 Scholarship Award
- One-on-one support from Schoolhouse Connection staff
- Three all-expense paid trips
- Support from Schoolhouse Connection Scholars
- Opportunities to engage in State and Federal policy advocacy

ELIGIBILITY

- You are currently residing in the United Stated. Note: undocumented applicants are eligible
- You were born on or after November 24, 2003
- You will begin college for the FIRST TIME in 2024 (excluding dual-enrollment courses)
- You experienced homelessness in the last six years

EFC APPEAL

When you complete your FAFSA for the 2023-2024 academic year you are required to report 2021 income information.

If you have had a drastic change in income in 2022 or 2023 due to an unforeseen or special circumstance, the Department of Education and Moreno Valley College will allow you to have your financial assistance eligibility re-evaluated.

ELIGIBILITY

Each year, Moreno Valley College student Veterans may enter a contest to win a cash scholarship. Students must meet eligibility requirements:

- Discharged from the military honorably, medically, or under honorable conditions
- Currently enrolled with a paid student services fee
- List Moreno Valley College as home college

From Warrior to Scholar: The College Transition of a Military Veteran

How did your service prepare you for life as a college student? What transitional challenges did you face when leaving military service to pursue your education? How did you overcome these challenges?

GUIDELINES

Veteran students are asked to write an essay responding to this year's prompt.

Length: 1,000 - 1,500 words

Format: Typed, double line spacing, in MLA or APA format. Include your student ID (and no other identifier) in the upper right, and a page number in the bottom right. Save as a PDF or in Microsoft Word for upload.

HOW TO ENTER

Students complete their scholarship entry form online. Your submission form also includes requests for:

- Name, student ID and contact information
- A portrait photograph
- Proof of military discharge
- A short 150-word biography discussing your personal background, educational goals and inspirations

ACCEPTING AWARDS

If selected, winners must attend the Veterans Scholarship Breakfast on Thursday, November 9 at 7:30 am in the Student Academic Services Building, Room 121. Winners may bring up to two guests, free of charge. Parking is free the morning of the event.


SAP REQUIREMENTS AND FINANCIAL AID ELIGIBILITY



To remain eligible for financial aid, you must meet the minimum cumulative GPA requirement.



You must, at a minimum, receive satisfactory grades in 67% of cumulative credits attempted.



You must complete your program of study before attempting 150% of the credits required for your program.

SAP STATUSES



SATISFACTORY

You meet all requirements and are eligible for financial aid.

Keep up the good work!



WARNING

You haven't met one or more requirements for one term.
You're eligible for aid but you must meet all requirements by the end of the next term.



INELIGIBLE

You haven't met requirements for two consecutive terms and are no longer eligible. You may appeal to reinstate your financial aid.

TAKE ACTION


- Strive for a grade of C or better in all of your courses.
- Before you drop a class, check with Student Services.
- Maintain good study habits and continue towards your goal!

TAKE ACTION

- Evaluate what is preventing you from meeting academic requirements.
- Take advantage of your resources and visit with your instructors, financial aid, counseling, and tutorial services.

TAKE ACTION

- File a SAP Appeal through your financial aid portal at StudentForms.
- Meet with a Student Financial Services Counselor.
- Speak with Student Financial Services for assistance.



PRACTICAL STRATEGIES TO MINIMIZE COLLEGE COSTS

While exploring different ways to fund your college education is important, it's equally crucial to consider how you can manage and reduce your overall college costs. There are several strategies you can employ to keep your expenses in check.



Buy Used Textbooks or Rent Them

Consider the library or buying used books or renting them from websites like Amazon, Chegg, CampusBooks.com, and BookFinder.



Buy Discounted Computers

Some colleges offer free or discounted laptops to incoming students. Remember to have your student ID or other proof of enrollment ready when making a purchase.



Maximize Your Course Load

If you can handle the workload, taking more classes each semester can help you graduate earlier and save money.



Live at Home or in a City With a Low Cost of Living

If your school is close to home, living with your parents might be an option. Use MoneyGeek's Cost of Living Calculator to compare expenses in hundreds of U.S. cities.

Manage Your Credit Card Spending

If you decide to use a credit card during college, <u>use it responsibly</u>. Aim to pay off your balance in full each month to avoid interest charges.



Stick to Your Budget

Creating and sticking to a budget is one of the most effective ways to control college costs. Use apps and online tools to track spending and stay on budget.



Use Public Transportation

If your school is in a city with good public transportation, consider using it instead of maintaining a car, which can be expensive. Many cities offer discounted or free transit passes for students.



Cook Your Own Meals

Eating out can quickly add up. Spending \$10 on lunch every day can amount to \$50 per week or \$200 per month. Additionally, cooking can be a stress reliever and a valuable life skill. Consider meal prepping on weekends to save time during the week.

Student employment can play a significant role in a student's education. Through on-campus jobs, you can learn valuable skills and build self-confidence that prepares you for your future careers.



WHAT IS IT?

Part-time opportunities to work on campus, earn money to pay for educational expenses, gain work experience, and have a flexible work schedule.

WHAT ARE THE REQUIREMENTS?

- MVC is your Home College
- Enrolled in 6 units (fall/spring)
- Enrolled in 3 units (winter/summer)
- Maintain a minimum cumulative 2.0 GPA
- Have a valid Social Security card and picture ID

Federal Work-Study positions also require:

- A complete FAFSA application and financial aid file
- Meet SFS Satisfactory Academic Progress (SAP) standards
