Dear President Perez:

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting January 11-13, 2011, reviewed the Follow-Up Report submitted by the College and the report of the evaluation team which visited Friday, November 19, 2010. The Commission notes that the College has resolved Recommendations 1 and 3, as identified in the Commission's action letter of January 29, 2010.

The Commission expects that at the time of the next comprehensive review visit, the College demonstrates the sustainability of its efforts as documented in the Follow-Up Report and confirmed by the evaluation team in its report. These include: the completion of the strategic plans and the implementation of a robust and comprehensive evaluation and assessment of student learning needs.

The Follow-Up Report will become part of the accreditation history of the College and should be used in preparing for the next comprehensive evaluation. I have previously sent you a copy of the Evaluation Team Report. Additional copies may now be duplicated. The Commission requires that you give the report and this letter appropriate dissemination to your college staff and to those who were signatories of your college report. This group should include the Chancellor, campus leadership, and the Board of Trustees. The Commission also requires that all reports be made available to students and the public. Placing copies in the college library can accomplish this. Should you want an electronic copy of the report, please contact Commission staff.


All colleges are required to file a Midterm Report in the third year after each comprehensive evaluation. Moreno Valley College should submit the Midterm Report by **March 15, 2012**.
