

## Disclaimers

According to the U.S. Department of Education, disclaimers should be added to any college-related recruitment piece distributed to students and/or the community. There are several different disclaimers used in different circumstances: Discrimination disclaimer, financial aid disclaimer, activity disclaimer, and Perkins Title I-C (370) disclaimer.

### **Discrimination disclaimer – short version**

*Include short version disclaimer on flyers, pamphlets, student services, counseling, career transfer center brochures.*

The Riverside Community College District does not discriminate on the basis of race, color, national origin, sex, disability, or age in its programs and activities. ### **Discrimination disclaimer – long version**

*Include long version disclaimer in multi-page documents like catalogs, class schedules, student handbooks. Use in places where space is not an issue.*

The Riverside Community College District complies with all federal and state rules and regulations and does not discriminate on the basis of ethnic group identification, national origin, religion, age, gender, gender identity, gender expression, race or ethnicity, color, ancestry, genetic information, sexual orientation, physical or mental disability, pregnancy, veteran or military status, or any characteristic listed or defined in Section 11135 of the Government Code or any characteristic that is contained in the prohibition of hate crimes set forth in subdivision (1) of Section 422.6 of the California Penal Code, or any other status protected by law. This holds true for all students who are interested in participating in education programs and/or extracurricular school activities. Limited English speaking skills will not be a barrier to admission or participation in any programs.
